Description of the activities that occur at your site:

The Office of Student Conduct facilitates and administers the behavioral expectations of Missouri State University students. We engage in conduct meetings, educational meetings, trainings, and conduct hearings.

Description of practicum students' duties at your site:

The duties may depend on whether or not you are an undergraduate or graduate student. If you are a graduate student, you will be able to sit in and facilitate conduct meetings with the professional staff – this option is not available to undergraduate students currently.

Some duties may include but not limited to:

- Special assigned projects – topic research, creation of reports, creation of training sessions and materials, creation of publication materials, developing creative consequence information, creation of manuals, etc.
- Investigations – facilitating interviews with students who have been identified as witnesses in certain situations.
- Reports – writing and editing investigation reports. Reading and interpreting incident reports
- Conduct meetings – facilitating conduct meetings (when ready)
- Meetings – attend department meetings, university meetings, committee meetings when necessary

Due to the nature of the work and pace of the environment, projects may come up as well.

Type of population with which students would be working (e.g., adults, adolescents, children, physically challenged, cognitively challenged, etc.):

Our population includes undergraduate and graduate students as well as student organization conduct. Student organizations include fraternities and sororities as well.

Our Students

Undergraduates

Our undergraduate students typically are juniors and seniors with 17-35 credit hours in Psychology. There are exceptions. If you have any special requirements for students who apply at your practicum site, please describe them.

Graduate Students
