*I function in the Ozark R-VI school district as the “district psychologist.” I am a trained and licensed clinical psychologist with about 14 years of clinical experience in an outpatient facility doing therapy and evaluations. This is my sixth year working fulltime as a school psychologist. I also teach adjunct college classes at both the undergraduate and graduate levels. I feel that a practicum experience with me would be particularly beneficial to a student who is trying to decide on a career path in this field because I have a wide range of experiences, including both clinical and school-based. This allows me to share first-hand knowledge and insight that might be unique and valuable as the student chooses a course of study. I also have many professional connections with persons in related human services fields (e.g., occupational therapists, physical therapist, speech/language pathologists, school counselors, social workers, licensed counselors, etc) that I would gladly arrange to meet with a student who might be interested. In the past few years, I have assisted several students in the graduate school application process.*
